TWO OPENINGS – ONE FATE

The national school of population genetics belongs to the experimental discovery of two fundamental phenomena that are persistently suppressed by the supporters of the "evolutionary theory", "Synthetic theory of evolution".

1. 36 years ago, our compatriot, the founder of the School of Population Genetics, Academician of the Russian Academy of Sciences, Yuri Petrovich Altukhov, opened the PHENOMENON OF THE GENETIC MONOMORPHISM TYPE. This phenomenon proves that for the preservation of each species of animals on the planet Earth, each dividing cell of an organism of one kind or another must preserve the FUNDAMENTAL – MONOMORPHIC – PART OF THEIR GENOM, about 30%. Otherwise, degeneration and death (disappearance) of a species or population.

2. 30 years ago, another Russian compatriot, Moscow biologist, Ph.D. in biology, Evgeni Nikolaevich Khachaturov, discovered the phenomenon of hemolytic half-DNA, contained in the nucleus of the first order, in the process of spiromyogenesis in animals. This phenomenon proves that some "external force" – "consciously" carries out a presigot selection in each (!) Dividing sex cell of each (!) Male of the animal world, from insects to humans inclusive.

In other words, Yu.P. Altukhova shows that in order to preserve species - in nature it is maintained QUANTITIO (!) Somehow a GENE MONOMORPHISM. And the discovery of E.N. Khachaturov shows that it is for this (!) In nature that there is – QUANTITATIVE DETERMINED – PRESIGITAL BREEDING, THERE IS A SELECTION AT THE LEVEL OF GAMETTE.

Thus, these two FUNDAMENTAL OPENINGS of domestic geneticists are COMPLEX, mutually complementary.

This is their quality of complementarity is THE DECISIVE ARGUMENT, which reduces the anti-scientific hypothesis of the "evolution of species", or the so-called "Synthetic theory of evolution".

In addition, the existence in nature of both detected biological phenomena unequivocally indicates their fundamental anti-mutational role. Therefore –

Here is what is said in the textbook for university biofacies (Yu.P. Altukhov, "Genetic processes in populations", Moscow, Nauka, 1989): *"If we recognize the existence of a monomorphic part of the genome, then the place for Darwinism as an evolutionary theory is not at all remains"* (page 369).

But what is said in the monograph E.N. Khachaturova ("Elimination of a significant part of DNA during the change of nuclear forms in the life cycle of the development of organisms." Moscow, Publishing House "Public Benefit" of the Russian Physical Society, 1995):

"With the use of morphological and cytofluorimetric methods of investigation, it was found that in representatives of classes of birds, reptiles, amphibians, fish, mollusks and insects, as a result of meiosis divisions from the spermatocyte of the first order, not four but only two haploid spermatozoa are formed; while half of the amount of DNA contained in the nucleus of the spermatocyte of the first order eliminates.

Elimination of half the amount of DNA contained in the nucleus of a spermatocyte of the first order, in the process of spermiogenesis in animals, apparently indicates the existence of prezygotic selection, that is, selection at the gamete level" (p. 135).

Both of these outstanding discoveries are of high priority for an objective interpretation of today's most difficult environmental situation on the Planet; and above all – for an objective assessment of the perspectives of the very existence of the species homo sapiens in the face of an ever-growing "mutational press" on the human genome.

Two discoveries – one fate. The fate of all mankind.

Enough to play hide and seek, criminally suppressing the scientific foundations of speciation!

Let's abandon our selfish worldview ambitions and preferences!
